3. All other documents in your files pertaining to these matters which are part of the public record.

The term "documents" as used in this FOIA request is to be construed in the broadest possible manner and includes any written, graphic, or recorded matter, however produced or reproduced, of any kind or description, including both sides of any two-sided writing, drafts and marked copies.

If there are any fees for searching for the records I have requested, please advise and we will remit those fees at once, so long as the cost is within the limits of the Freedom of Information Act. If you believe that the volume of material contained in your file is so great that it would result in costs in excess of \$100.00, please notify me so that I may personally review the file or otherwise attempt to narrow the scope of this request.
